

Since my appointment in September 2022 as District Recorder, I have enjoyed the opportunity to attend almost every meeting of the Chapters in the District of West Kent. I graciously thank V Ill Bro Graham Higgs 33° for identifying me as a possible candidate to take the office and I also readily acknowledge the friendship and professionalism demonstrated by my predecessor in office, Ill Bro Bob Jones 32°.



I was Perfected in to my 'Mother' Chapter, Fidelis ad Finem No. 263 in London on 7th March 2002 and after a somewhat unorthodox progression to the Office of MWS I then served 10 years as the Recorder.

I joined Kent Chapter No. 1071 where I served as Assistant Recorder for 5 years and then Recorder for 5 years. I am currently the Recorder for Weald Chapter No. 842 (in the District of East Kent) and Money Chapter No. 76. I believe that the Recorder is the 'heartbeat' of a Chapter, a role that I relish.

Of course, much has happened since my appointment as DR, the most significant event being the Investiture of V III Bro Mark Eyles-Thomas 33° as our new IG and I much enjoyed working collaboratively with Officers of Westwood Chapter to ensure that the meeting was a success and enjoyed by our new Inspector General. I fully support his desire to allow all the brethren the opportunity to learn the various changes now introduced into the 2024 edition of the Rose Croix ritual and so to be confident when participating in ceremonies of Perfection or Enthronement. I currently host the fortnightly Chapter of Improvement evenings held at Oakley House and have been greatly impressed by the commitment of the brethren who attend and have noticed a significant increase in the self-confidence they demonstrate when conducting various sections of the ceremony. Everyone takes part and I am sure there is a 'private challenge' to catch the DR out with some challenging questions or observations!!, I welcome these which demonstrate that the brothers are engaging with all aspects of the ritual - well done. So, as I work with all the Chapter Recorders and their members, I thank you for your support and look forward to working with you and supporting you in the years ahead.

A PROFILE OF V. . III. . . BRO MARK ROBERT JASON EYLES-THOMAS 33° INSPECTOR GENERAL - DISTRICT OF WEST KENT

V∴ Ill∴ Bro Mark Eyles-Thomas 33° was born in Rochford in 1964 to parents who were both teachers, he attended Leigh Academy, Dartford.



A talented youth athlete, Mark played cricket for Kent, playing two years above his own age group; from U15s he captained

the side. Mark was elected a playing member of the Marylebone Cricket Club (MCC) and has represented the MCC in European matches, as well as Kent County



Cricket Club Veterans, touring South Africa, and Barbados.

After O-levels, he joined the Parachute Regiment, aged 16, but soon transferred to the adult Recruit Company to undertake the infamous Pre-Parachute Selection course (P Company).



His platoon passed out in January 1982, and he joined the 3rd Battalion the Parachute Regiment in Tidworth, Wiltshire.

Only two months later, Mark embarked on SS Canberra and was on his way to the Falkland Islands along with four comrades from the same intake.


Three of them fell in battle, and Mark's platoon Sergeant received a posthumous Victoria Cross (VC).

Mark celebrated his 18th birthday on MV Norland on the return voyage.

He was awarded the South Atlantic Medal with Rosette and has received five Freedoms of the City (Gosport, London, Portsmouth, Plymouth, and the Falkland Islands).



After serving a further three years, he left the Army to start a security company which specialises in electronic fire and security systems and holds 6 NSI Gold Medal Awards (the only UK Company to do so).



He remains its Managing Director and is a Liveryman of the Worshipful Company of Security Professionals (WCoSP), he is also a member of the Honourable Artillery Company (HAC).





Mark married Patricia in 1990, and his son and daughter have followed somewhat in his footsteps. Dominic is serving, and Cher-Leigh joined the family firm after a period working at the Imperial War Museum.





Mark was Initiated in Universal Lodge No. 8219 (West Kent) in 1989 (Master in 2000) and is a subscribing member of eight Craft Lodges (six in West Kent and two in London, Regularity No. 91 and Fitzroy No. 569). In 2012, he was appointed Provincial Grand Mentor, was promoted Assistant Provincial Grand Master in 2016 and served as Deputy Provincial Grand Master from 2018-22. V W Bro Mark



holds the rank of Past Grand Sword Bearer in UGLE. He is also an honorary member of twenty other craft Lodges.



Mark was Exalted in Universal Chapter in 1997 (Z in 2012, 19, 20 & 23), he is a subscribing member of four Royal Arch Chapters in West Kent and was invested as Past Grand Standard Bearer in Supreme Grand Chapter in 2020. Mark is also currently Z in 2 other Chapters (at the time of writing the profile - Ravensbrook &

Regents Park Meridian). He is also a member of Greenwich Lodge of MMM No, 332 and its associated RAM Lodge.



In the Ancient and Accepted Rite, Mark was Perfected in Westwood Chapter No. 764, West Kent, in 1998 (Most Wise Sovereign in 2015, 18, 19 & 20) he was their Recorder from 2022-2024. Mark is also a member of Kent Chapter No. 1071, Money Chapter

No. 76, Sitis Pro Scientia Chapter No. 1213 (East Kent) & Suprema Lex Chapter No. 1000 (London).

He was the representative candidate for his 30° ceremony and was promoted to the 31°, 32° and 33° in 2024.

Mark was appointed Inspector General Designate in Charge for West Kent as of the 1st June 2024 and was installed as Inspector General on the 8th July 2024.

THE WAY FORWARD – NEXT STEPS

Princes, as we all know the recent changes introduced by Supreme Council last year has resulted in tremendous changes to our membership profile now that we are able to welcome new members from all religious backgrounds. We all remember the day when we were invited to join this wonderful Order. The pride we felt when our sponsors thought we had the right moral credentials to become members, it was and still is a privilege to call ourselves Princes. Then like now the baton has been passed to us to seek out new members from within our ranks and of the wider community, at the same time reinforcing that our Mantra is and always will be 'High Standards', in everything we do.

Membership is key to our Districts stability and success. In the past, approximately 10% of our Orders membership has flowed from the Provincial Craft and I would initially like to see our numbers return to this level. We currently obtain around 8%, to this end I would like you to consider inviting suitable members from you Craft Lodges to join us here in the District of West Kent.

ACCEPTED AT LAST: MY JOURNEY INTO THE ROSE CROIX

It's official! I'm now a member of the Ancient and Accepted right here in London. This is a moment I've been anticipating for years, and it's even more significant than I could have imagined.

You see, my interest in the A&AR, or Rose Croix as it's often called in England, was sparked long ago by a visit to the House of the Temple in Washington DC (the headquarters of the Scottish Rite Southern Jurisdiction in America).

captivated was their by philosophy and commitment to philosophical Masonic exploration and to Freemasonry as a path of truth and virtue. Most of all, I was impressed by the members themselves. In fact, two of my Masonic heroes, Ill Bro. Brent Morris and Ill Bro. Art DeHoyos, are prominent members the Southern Jurisdiction, and their work has been a source of great inspiration for me. But there was a hurdle. The rules for joining the Rose Croix in England, which traditionally required a specifically worded Trinitarian Christian obligation, prevented me from feeling genuinely comfortable



taking that step. However, exciting changes have recently swept through the Supreme Council 33° for England and Wales. As of March 1st, 2024, the order opened its doors to Master Masons of all faiths, bringing it in line with the global practises of the Ancient and Accepted Rite. This was the catalyst I needed.

A Shared Moment of Joy:

Not only did this change inspire me to finally join, but it also opens the door for my new friend and Brother, Sami Steinbock, who is Jewish. Side-by-side in the Chapter, witnessing him take his obligation on the Torah, was a powerful and

moving experience. It felt like a true testament to the universality of Freemasonry and the inclusive spirit of the reformed Ancient and Accepted Rite.

Why This Matters:

This shift in the Rose Croix is momentous. Flex our broader recognition within freemasonry of the importance of inclusivity and respect for all faiths. It allows brothers from diverse backgrounds to come together, united by their shared love of the Craft and their desire to explore its deeper meanings. While I know not everybody agrees with the new rules for membership, I believe it's

a profoundly positive step forward. It strengthens our fraternity and reflects the true spirit of brotherhood and reflects the rules for this degree in most other countries.

Our Journey Begins:

Sami and I are still in the early stages of our journey through the degrees, but we're already deeply impressed by the richness of the ritual and the depth of the symbolism. The Rose Croix offers a unique perspective on Masonic into teachings, delving philosophical and mystical concepts that expand upon the foundation laid in the Craft degrees. And I have to say I was both completely thrown by but also loved the ritual! It's dramatic and flamboyant, and with it's French origins, it has a certain je ne sais quoi that sets it apart. The combination of history, symbolism, and theatrical flair creates truly captivating experience.

What makes the Rose Croix ritual particularly unique is the way it unfolds. With its many changes of scenery, it's quite unlike anything else in freemasonry it's a true spectacle that engages the senses and draws you deeper

into the narrative. I found myself completely immersed in the drama, and I believe that the more contemplated and reverent the approach, the more you will get out of this incredible ritual. In fact, having witnessed the Rose Croix degrees I can't help but wonder if elements of this captivating ritual might have found their way into the SRIA. The similarities are a few props, and routine seems to be more than a coincidence.

More than just a ceremony, joining the Rose Croix has felt like a real adventure that Sami and I have embarked on together. Sharing this experience, witnessing the degrees unfold side-by-side, and discussing our interpretations afterwards have created a bond between us that I truly cherish. It's been an incredible

opportunity to not only learn more about Freemasonry but also to meet others. Sami is a joyous individual, and his response to things complements my deeply meditative one well. I wonder what the next ritual we will witness together at this degree will be?

An Unexpected Inspiration:

Beyond the Masonic lessons, the Rose Croix ritual has made me look at a few things in a different way. It has rekindled my interest in some sections in the New Testament and filled me with a renewed appreciation for the teachings of Jesus. The degree explores themes of Faith, Hope and Charity, and it has inspired me to reflect more deeply on these virtues and how I can better embody them in my own life.
